Replacement of Debit & ATM Cards

West Financial debit card holders will be mailed MasterCard[®] EMV debit and ATM cards in mid-October. Hold this card in safekeeping until it can be activated on October 26.



Last Day to Schedule/Edit Payments in West Financial's BillPay System

You may schedule or edit payments up until 4:00 p.m. (CST) on Wednesday, October 24. Anything scheduled with a payment date after October 24 will not be processed. Download or print any account information, payees, records, or history you may need to re-establish these payees on SharePoint's BillPay system.



Card Activation & Usage

On Friday, October 26, you will need to activate your new SharePoint debit or ATM card.

• 6:00 a.m. (CST) or after: Activate your new SharePoint card.

• **2:00 p.m.** (CST) **or after:** Begin using your active SharePoint card, as your West card will no longer work.

You will need to update any automatic payments made with your debit card with the new account information. Business debit cards and ATM cards will also follow this process.

On Monday, October, 29, members can enroll in Internet Banking as outlined on page 4 or by using our Mobile app. You may begin setting up bill payees and scheduling payments at this time.



Replacement of Credit Cards

Your new Visa® Credit Cards will be issued in January 2019. Your current West Credit Card will stay active until January 2019. You can access your current credit card account online by visiting www.ezcardinfo.com.

GENERAL ACCOUNT INFORMATION

» Account Number

For your security, your West Financial account number(s) will be changing to SharePoint's numbering pattern. **We will be mailing your Account Numbers in a separate mailing prior to October 29.** You may continue to use your current check stock.

» Routing Number

The current West Financial routing number 291074654 will remain active for a limited time. At your convenience, please update your records, using SharePoint's routing number: 291074984. You may continue to use your current check stock.

» Internet Banking/BillPay

You will have access to our convenient Internet Banking, BillPay and Mobile Banking app. Information from any similar West Financial services will **NOT** transfer over. To use SharePoint's services, you will need to enroll in Internet Banking as described on page 4 or by utilizing our Mobile app. West Financial's Internet Banking will no longer be available as of 5:00 p.m. on October 26.

For West Financial's BillPay service, the last day to submit a payment will be up until 4:00 p.m. (CST) on Wednesday, October 24.

» Automatic ACH Account Withdrawals/Direct Deposit

An **automated payment** (or ACH) is a regular, ongoing payment that is initiated externally to or from your SharePoint account, such as a monthly utility payment or auto loan payment. Contact your bill payees to update your account information.

A **direct deposit** is any payment that you receive directly into your account, like payroll, dividend or government direct deposits (e.g., Social Security). Contact your payroll department to update your account information.

SAVINGS & DEPOSIT PRODUCTS

Your West Financial savings and deposit accounts, including business accounts, will be transitioned to similar savings and deposit products with SharePoint.

» Share Savings

Your West Financial primary savings account will convert to a SharePoint primary savings account; earning the current SharePoint savings rate. The minimum share amount will change from \$25, to \$5.

» Money Market

Your Money Market account will transition to the corresponding SharePoint tier and rate.*

» Certificates of Deposit (Share & IRA)

Your West Financial certificates will continue at the current rate and term until maturity. At maturity, certificates will auto-renew for similar terms at current rates. You will receive information thirty days prior to the maturity date of your certificate.

» Individual Retirement Account (IRA)

Rates, terms and all other conditions of your IRA account remain as agreed.

CHECKING ACCOUNTS

» Debit & ATM Cards

Your new SharePoint MasterCard[®] debit card or ATM card will be mailed mid-October to the address on record. On Friday, October 26, you will need to activate your new SharePoint debit or ATM card.

- 6:00 a.m. (CST) or after: Activate your new SharePoint card.
- **2:00 p.m.** (CST) **or after:** Begin using your active SharePoint card, as your West card will no longer work.

» Automatic Debit Payments

Automatic payments you have set up using your debit card (iTunes[™], Netflix[™], etc.) will need to be updated beginning Friday, October 26, with your new MasterCard[®] debit card information.

» ATM Access

Members will have access to the MoneyPass[®] ATM Network, which offers more than 25,000 surcharge-free ATMs nationwide, including all U.S. Bank[™] locations, Walmart[™] and Kwik Trip[™] stores. Locate an ATM and find information at sharepointcu.com, or on our SharePoint Mobile app.

» Cash Back at the Register

You can get cash back at participating merchants on the STAR network by simply selecting "debit" at the time of checkout, entering your PIN and requesting cash back. There is no fee for this service; the cash back amount limit will vary at the discretion of the merchant and your available funds.

STATEMENTS

You will receive two paper statements for the month of October. The first will be your final statement from West, with transactions until October 26. The second statement will come from SharePoint, with your transactions from October 27-31.

If you currently receive eStatements, please save or print copies you wish to retain by October 26, as your access to past eStatements will end. SharePoint offers eStatements, and you can opt-in to this service once you complete your Internet Banking enrollment process.

CONSUMER LOANS

As of October 29, any loans you currently have with West Financial will automatically convert to SharePoint; the terms and agreements will be honored, although the account numbers and product names may change.

» Auto/RV/Motorcycle

Your current loans will continue with the same terms, although your loan number(s) will change slightly. **You may make payments:**
